MEMORANDUM

Sub: 2nd Instalment towards allotment and sanction of residual 50% of the Stream I projects under Rashtriya Krishi Vikas Yojana for the year 2009-10.

The undersigned is directed by order of the Governor to say that the Governor is pleased to accord allotment, sanction and release a fund amounting to Rs.1902.0055 lakh (Rupees nineteen crore two lakh five hundred fifty) only towards the residual 50% of Stream I projects for implementation of schemes under Rashtriya Krishi Vikas Yojana for Agriculture Department during the year 2009-10 as per Annexure.

The above sanctioned fund Rs.1902.0055 lakh is placed at the disposal of the Director of Agriculture who will further sub-allot the fund directly to the concerned Drawing and Disbursing Officers as per Annexure.

The expenditure of the above sanctioned fund of Rs.1902.0055 lakh will be met from the Head of Account of – “2401-Crop Husbandry-00-109-Extension of Farmer’s Training-SP-State Plan (Annual Plan 10th/11th Plan)-031-Additional Central Assistance Scheme under Stream-II of Rashtriya Krishi Bikash Yojana-31-Grants in aid-02-Other Grants” under Demand No.5; **Key Code - “2401-00-109-SP-031-V-31-02”**. An excess amount of Rs.301.725 lakh thereunder will be met by way of reappropriation or otherwise in due course. This excess amount should be surrendered from the savings under the Capital Head of Account – “4401-00-104-SP-004-V-53” under same Demand No.5. The total fund will be drawn in grant-in-aid bills.

Utilization Certificate of the amount spent may be sent to this Department in due course along with the physical and financial reports through the Director of Agriculture, West Bengal before release of next instalment.

Project-wise accounts are to be maintained and inventory of the assets created under the projects should be carefully preserved.

This Order issues with the concurrence of the Finance Department Group ‘N’ vide U.O. No.2548 dated 19.02.2010.

The above sanctioned fund will be expended for the approved schemes maintaining the following norms strictly :-

1. Usual financial rules including tender norms,
2. Physical and financial progress reports are to be furnished on quarterly basis.
