Sub : Sanction and release of fund of Rs.3,07,30,782/- for distribution of Different Seed Kits to enhance productivity during Rabi 2009-2010.

The undersigned is directed by the order of the Governor to say that the Governor has been pleased to accord sanction, allot and release an amount of Rs.3,07,30,782/- (Rupees Three crores seven lakh thirty thousand seven hundred and eighty two) only out of total proposed fund of Rs.4,26,05,525.00 (Rupees Four crores twenty six lakh five thousand five hundred twenty five) only for distribution of quality seed kits to enhance productivity in different districts during Rabi 2009-2010. The balance amount will be considered for release in the last quarter of the current year subject to the submission of utilization certificate of the fund already released and availability of the concurrence of the Finance Deptt. for the same.

2. The Director of Agriculture, W.B. is hereby authorised to sub allot the above fund, sanctioned and released herein to the concerned Drawing & Disbursing Officer(s) as per requirement of different districts.

3. The entire fund of Rs.3,07,30,782/- (Rupees Three crores seven lakh thirty thousand and seven hundred eighty two) only sanctioned herein, will be met from the following Heads of Account :-

Expenditure may be made out of the sanctioned amount by the respective D.D.O. in full satisfaction about admissibility, accuracy and justification of such expenditure and subject to fulfillment of Financial Rules. Necessary accounts and records of expenditure as per usual norms shall be maintained for purpose of Audit.

6. All DDA (Administration)/ADA (Administration) are hereby declared D.D.O. in the respect of the fund to be sub allotted to each of them by the Director of Agriculture, W.B. They will submit Utilisation Certificate to the Director of Agriculture, W.B. and the same will be submitted to this Deptt. by the Director of Agriculture, W.B. at an early date.
