Sub : Implementation of Central Sector Scheme of "Post harvest Technology Management" during 2009-10 through the deposition of released fund in the Deposit account of West Bengal State Seed Corporation Ltd.

Sir,

In cancellation of this Deptt's memo no. No.20(Sanction)-Inpt. dtd:08.12.2009 and order no.376-Inpt./2S-07/09 dtd:19.02.2010 on the above cited subject, undersigned is directed by Order of the Governor to say that the Governor has been pleased to accord sanction as well as release of an expenditure not exceeding to **Rs.70.45 lakh (Rupees seventy lakh forty five thousand only)** towards implementation of the component of 'Demonstration' and 'Establishment' under the Central Sector Scheme on "**Post Harvest Technology and Management**" in the State of West Bengal during the financial year 209-10.
