With reference to your Memo No. 988-Res. Dated 26.11.2009 and further Memo No. 32 dated 23.02.2010 of Agronomist, Dry Land Research Station, Bankura on the above matter, I am directed by order of the Governor to say that the Governor has been pleased to accord administrative approval of the proposal of purchasing research instruments as stated at Annexure-II at DLRS, Bankura at a total cost not exceeding Rs. 13,32,562/- and sanction as well as release of an amount of Rs. 11,07,562.00 (Rupees Eleven lakh seven thousand five hundred sixty two) only out of total approved amount for purchase of research instruments as stated at Annexure-I under the "Infrastructure Development of Soil and Fertiliser Testing Facility" during 2010-2011.

3. The above fund will be placed at the disposal of the Agronomist, Dry Land Research Station, Bankura and he will act as D.D.O. for the above expenditure.
